




PUBLIC MEETING NOTIFICATION

Rehabilitation of Eastern Avenue NE

(from New Hampshire Avenue NE to Whittier Street NW)



PROJECT BACKGROUND

Eastern Avenue is a boundary street between Washington DC and the state of Maryland. The District Department of Transportation (DDOT), in support of DDOT's moveDC plan and the Mayor's Vision Zero Initiative, is working to create a safer, more livable, sustainable and attractive corridor. This project is in the design phase.

PROJECT OBJECTIVE

The project objective is to increase multi-modal (pedestrian, bicyclist and motorist) safety and to improve the corridor's appearance and functionality with new pavement and granite curbs; new sidewalks; addition of bicycle lanes; improved lighting; and new streetscape elements, while reducing vehicular speeds with curb extensions, signal upgrades and pavement markings.

PROJECT DESIGN ELEMENTS

- ADA improvements and enhancements
- Pavement reconstruction
- Street and traffic light upgrades or modifications
- Installation of new gutters, sidewalks and granite curbs
- Improving signage or pavement markings
- Upgrading existing catch basins to a larger capacity
- Intersection safety improvements
- Overall improvement of pedestrian and motorist safety
