









ENTRY LEVEL FLOOR LAYOUT




UPPER LEVEL FLOOR LAYOUT



 Large (Bradford pear) tree informed the design footprint of the new building.

 This tree was intended to remain and was safeguarded during demolition.

Following the removal of the building, the previously hidden root structure was under evaluation by Arborist, Urban Forestry, & DDOT and week of April 12, they all agreed tree was a safety hazard

May 2021




An expedited tree removal permit filed & received, tree removed.

A mature tree is planned to be transplanted in the proximity of the old tree

NEXT FEW WEEKS:


- Utilities work on Kennedy St and South Dakota Ave June.
- Approved traffic control plans will be provided prior to the start of this work.
- **Crane onsite** within the project perimeter for steel erection.
- Steel erection starting in upcoming weeks.
- Underground utility, electrical, and plumbing work is ongoing.
- Excavators will remain onsite and concrete trucks & pumps will be onsite during pour days.
- Trucks will still enter and exit the site via South Dakota Avenue into the construction enclosure from Kennedy St.
- The sidewalk on South Dakota, Jefferson St & Kennedy St. will continue to remain open for the foreseeable future.
