#### Mission of Food & Friends:

To improve the lives and health of people with HIV/AIDS, cancer and other serious illnesses that limit their ability to provide nourishment for themselves by:

- -providing nutritional counseling and wellness education that enhances our clients' quality of life; and
- -creating a strong sense of community for both our clients and volunteers that reduces the social isolation that often comes with serious illnesses and provides meaningful opportunities for neighbors to help neighbors in need.



#### **Project Overview:**

Food & Friends is excited to introduce plans for a curb cut project aimed at enhancing accessibility, improving the flow of traffic, and increasing traffic safety around our building at 219 Riggs Rd. NE. This initiative underscores our commitment to staying in the neighborhood as a bedrock nonprofit while serving more adults and children with life-challenging illnesses.

The proposed project for a curb cut on South Dakota Avenue NE improves Food & Friends' site accessibility. Neighborhood safety will be increased as speed is reduced, a solution that helps meet the neighborhood's much requested traffic safety fixes at a congested intersection and the site of a planned neighborhood park.

We will engage the community respectfully and transparently throughout the project's lifecycle, ensuring that community input is valued, as we do every day with our clients.




# 2023 impact snapshot


Together, we are neighbors helping neighbors. Thanks to our community, Food & Friends has

successfully responded to surging demand for medically tailored meals and groceries from adults and children with life-challenging illnesses throughout D.C., Maryland, and Northern Virginia. With your support, we have increased our annual meal production by 75% in a period of just four years.

Food & Friends is built on a simple premise: anyone can get sick, and everyone can help.

In FY 2023, Food & Friends home-delivered 1,900,000 medically tailored meals to 5,500 seriously ill individuals in the District of Columbia, Maryland and Virginia. Our clients have a range of illnesses including cancer, diabetes, renal disease, HIV/AIDS, maternal health concerns, and heart disease.
