Tax Preparation Services for DC Residents at Lamond-Riggs Library Available 2/2/2026 – 4/15/2026

What You Need to Know	
DC Residents Only	At this site, we only prepare returns for taxpayers who resided in DC on December 31, 2025.
Out of Scope	We cannot prepare your tax return if, in 2025, you: a. Earned income from permanent rental housing; b. Lost money from self-employment; c. Sold digital assets or bought them other than by cash; or d. Need to file a Form 1040-NR return.
One Trip, In-person Tax Preparation	Before coming to Lamond-Riggs Library for your appointment, you must complete the 10-page Intake Booklet and appropriate worksheets. While you are here, we interview you, prepare your return, review the return with you, have you sign it, and give you a copy to take with you. We eFile your return. We only prepare paper returns as required by the IRS or DC OTR.
BY APPOINTMENT ONLY	Appointments are available on Mondays and Wednesdays between 11:00 am and 3:00 pm. Be sure that you have, or will have, all your TY2025 tax documents before your appointment. You may make your own appointment using the AARP online system at bit.ly/L-RLAppts . Or, you may send an email to 20051013@aarpfoundation.org or come to the meeting room on Monday or Wednesday afternoons (starting Feb 2) to set up your appointment. We do not make appointments by telephone or text.
Amended Returns	We only prepare amended returns for those originally prepared at Lamond-Riggs or Petworth Libraries.
TY 2022, 2023 and 2024 Returns	Be sure to mention your need for a TY 2022, 2023 and/or 2024 return when making your appointment.
WARNING: Restrictions on Paper Checks	The IRS is strongly encouraging taxpayers to use direct-deposit or direct-debit in lieu of paper checks to avoid extensive delays and complex processing.

Documents to bring to your appointment

- ☐ Form 13614-C - Intake/Interview & Quality Review Sheet (available online and at all sites)

Must be completed, with all questions answered, before we can prepare your return

Personal information:

- ☐ Photo ID with date of birth for each adult
- ☐ Social Security cards (or SSA-1099) for you, your spouse, and your dependents
- ☐ Copy of last year's Federal and DC/state tax returns for you and your spouse
- ☐ Bank account number and routing number, if depositing your refund directly into your account
- ☐ Any letters from the IRS (especially PIN notification)
- ☐ Form 1095-A if health insurance was purchased through the ACA Marketplace
- ☐ Record of estimated tax payments made to Federal and DC/state governments

Information about your income and that of your spouse and any dependents:

- ☐ SSA-1099 for Social Security benefits received
- ☐ 1099-R for payments/distributions from IRAs or retirement plans. Provide date of retirement
- ☐ 1099-INT, -DIV, -B, -S, or -K-1s for investment or interest income
- ☐ 1099-G forms for unemployment income, state or local tax refunds, gambling winnings
- ☐ 1099-C forms for cancellation of debt
- ☐ W-2, 1099-NEC, and 1099-MISC income forms
- ☐ Final pay stub from all employers if you had tip income or overtime income

Deductions and Credits:

- ☐ Itemized Deductions (Sch A) Worksheet (if claiming more than \$15,750)
 - ☐ Major medical expense documentation; health insurance and Long Term Care premiums
 - ☐ 1098 mortgage interest and tax form or government-issued property tax statement
 - ☐ Documentation of charity donations
- ☐ Documentation of energy efficiency home improvement expenses
- ☐ December rent receipt, plus landlord information (name, address, phone number) – D.C. residents

For students:

- ☐ Form 1098-E for student loan interest paid (or loan statements for student loans)
- ☐ Form 1098-T for tuition and other education expenses
- ☐ Loan forgiveness letter

For teachers:

- ☐ Some documentation for expenses paid for classroom supplies, etc.

For self-employed (including gig workers, such as for Uber, DoorDash, etc.):

- ☐ Self-Employed (Sch C) Worksheet
- ☐ Business income and expenses; papers from TaskRabbit, Lyft, etc. Mileage records
- ☐ Self-employed health insurance premium payment record
- ☐ 1099-NEC forms for you and your spouse (for any independent contractor work)
- ☐ 1099-K forms you receive from third-party payment sources (such as PayPal, eBay)

For parents:

- ☐ Childcare costs: provider's name, address, tax ID, and amount paid for year
- ☐ Adoption costs: SSN of child; records of legal, medical and transportation costs
